4. SCHEDULED ITEMS FOR DISCUSSION

a. 2021 Project Review - I. Drewnitski and M. Taylor

I. Drewnitski and M. Taylor provided a presentation regarding 2021 Project Review for Active Transportation initiatives. The project areas included Eighth Line, Sinclair Avenue, Barber Drive, Maple Avenue, Guelph Street, the Fairy Lake Dam deck, Hungry Hollow Trails – Maple Avenue to Park Avenue and West Branch Drive park to Main Street.

b. Hungry Hollow Trails - Dogs off leash

Councilor J. Fogal advised that this has been brought to Enforcement staff's attention. M. Taylor advised that adding 'dogs on leash' and 'poop and scoop' signage below all standard signage that is currently installed has been discussed and the target is to have signage up by the end of the year.

c. Donation from Epic Tour

Councillor J. Fogal advised that Epic Tour has provided the Town with a donation as a thank you to Bike It committee members for volunteering their time to run a pit stop for the Epic Tour. The Active Transportation committee and Bike It sub-committee will use the donation towards their work plan to help with cycling initiatives.

1. Call to order

Long noted that the Town works with organizations wanting to host events and supports them through the application process. Councillor J. Fogal advised that Transportation/Traffic staff should also be involved when planning a cycling even in town. Councillor J. Fogal suggested adding contact information to the Cycling Webpage for organizations looking to host events. A. Graham suggested that information can also be adding to the Cycling webpage on the Visit Halton Hills website. The committee will review this webpage at their next meeting and bring forth their feedback in the new year. Danica from Epic Tour advised that she can provide A. Graham with various cycling photos for use on the webpages. Councillor J. Fogal announced that Danica from Epic Tour was providing the committee with a cheque as a thank you for their time volunteering during the Epic Tour.

1. Call to order

Councillor J. Fogal called the meeting to order at 7:25 p.m.

2. Declarations of pecuniary interest

There were no disclosures of pecuniary/conflict of interest.

3. Approval of the minutes of the November 11th, 2021 meeting

The committee approved the minutes from the November 11th, 2021 meeting.

- 4. Business arising from the minutes

 - **b.** New event idea M. Collins Will have discussion at next meeting when 2022 events are being planned.

c. Hungry Hollow Trails - dogs off leash

Councillor J. Fogal noted that signs will be installed and that the locations of the off-leash dog parks in Halton Hills should be listed on the signs.

5. Pavement markings on multi use path - Main Street South

M. Roj discussed markings on multi use path where it says 'Slow' on Main Street South. These markings are there due to the driveway at RJ Mufflers, with vehicle traffic coming in and out as well as complaints that have been received from the public regarding high speeds that cyclists were picking up coming down the hill. The 'Slow' is a way of reminding people to not keep their speed too high. G. Price-Jones noted that the pedestrians need to ensure that they are not taking up the whole pathway as with larger groups walking on that pathway that leaves no room for cyclists. M. Roj noted that there are signs reflecting a cyclist/pedestrian path sharing down the multi use path. M. Roj suggested that he can work with Communications to treat this as an education piece reminds pedestrians to share the multi use path. A. Stiehl noted that at the entrance of Cedarvale Park is also an issue for cyclists with motorists pulling out. M. Roj noted that this area can be assessed to see if cross walk lines should be added to ensure proper compliance. Councillor J. Fogal inquired if a sign can be added to note to look for cyclists/pedestrians on the multi use path. M. Roj noted that it can be something similar to signs in other intersections that say watch for cyclists and pedestrians when they see the crosswalk lines. M. Roj noted that it will need to be discussed with the Recreation and Parks department as they are responsible for the access points of the parks. M. Roj to provide an update to the committee on this in the new year.

6. Review of Cycling Webpage – Visit Halton Hills

The Committee review the cycling webpage on the Visit Halton Hills website. The list of suggested changes will be passed on to A. Graham.

7. Transportation & Public Works Update

Cycling Map – I. Drewnitski advised that cycling map has routes uploaded online. It will be user friendly soon and should be available online in January or February.

Push buttons by Mountainview and Dale Gate – I. Drewnitski discussed with staff and there is enough space for a wheelchair to go through.

10. Items for Discussion

Councillor J. Fogal discussed attending the Halton Region's Bike Summitt.

A. Stiehl asked if M. Roj could let the committee know the results from their meeting on Maple Avenue. M. Roj advised that one of the key points included the transition from the crosswalks onto the sidewalks and the grading. It has been built to the standards of 1.8 metres, but it would be useful to have them flatter and wider for better accessibility. This approach will be assessed prior to the next project. The second key point is that the bike lane in the north direction on Maple Avenue at Guelph Street is a solid line to the edge and will have to be fixed via dashed line. M. Roj noted that this will be fixed. Additional signage will be installed that will inform cyclists that the bike lane ends and will have additional pavement markings where cyclists can merge.

M. Collins inquired about the number of cars parking on Danby Road and blocking the bike lanes. M. Roj noted that signs will be installed in that area in the future to advise for no parking.

Councillor J. Fogal revisited the topic of the Bike Share feasibility study and advised that it has been taken out of the budget but that staff would still like to do their due diligence on this topic. Councillor J. Fogal suggested discussing with other municipalities who do have a bike share program or organizations who run bike share programs. A. Stiehl suggested speaking with Hamilton. I. Drewnitski to contact Hamilton and Toronto and find out who does the bike share program and get more information on characteristics of a community before they would consider trying to set up the Bike Share program. I. Drewnitski to look into for the New Year.

A. Stiehl suggested looking into different club type group rides or meet up groups. Councillor J. Fogal advised that this can be discussed at the next meeting when discussing events.
