Mayor R. Bonnette announced that Canada is recognizing the Platinum Jubilee of Her Majesty Queen Elizabeth II, marking her 70th anniversary on the throne. This will take place at Dominion Gardens Park in Georgetown, on June 2nd at 9:15pm. The 'Tree of Hope' will be lit up for the month of June through to July 2nd.
