## 2. Community Volunteer Appreciation Event

Mayor R. Bonnette announced that the Town of Halton Hills is pleased to acknowledge the contribution of our volunteers by hosting a community wide recognition event every 4 years. This year's event is scheduled for Thursday June 16th from 6:00 P.M - 8:00 P.M at Dominion Gardens Park. The Community Volunteer Recognition event is meant to celebrate and recognize the vital role of Volunteers in the Town of Halton Hills.

In keeping with the historic location and its history of seed and flower cultivation, the theme for the evening is 'Thanks a Bunch'. All community groups and their volunteers will be thanked for the special role they play each day through volunteering in our community. An invitation has been sent to community groups and their volunteers and all are welcome to attend.

This informal, drop-in event will include light refreshments, entertainment, and a stroll through Dominion Gardens.

#### 3. Pride Month

Mayor R. Bonnette announced that each year we recognize June as Pride month, and as in previous years, we raise the Pride flag at Town Hall. This year we have raised the Progress Pride Flag for the first time. The flag was designed by non-binary American artist and designer Daniel Quasar to celebrate the diversity of the 2SLGBTQ+ community and to call for a more inclusive society.

The flag incorporates an arrow pointing to the right to show forward movement and illustrate the progress that still needs to be made.

The arrow is made up of light blue, pink and white stripes to represent trans and non-binary people and brown and black stripes to represent Black, Indigenous and racialized people.

The black stripe has a double meaning and is also intended to recognize those living with HIV and those that have been lost to AIDS.

The flag represents the continuing fight for human rights and invites reflection on the diversity of the queer community and the importance of representation.

The Halton Hills Public Library is celebrating Pride with in-branch displays, featuring works by queer authors and creators through the RainbowReads Collection, and hosting a Positive Space Network Drop-in for youth. I am also pleased to announce the much anticipated return of Drag Queen Storytime with Fay and Fluffy on July 9th. For full details on Pride programming please visit the Library's webpage.

Pride month is a time for activism, celebration and education. I would like to recognize all of the Two Spirit, Lesbian, Gay, Bisexual, Transgender, Queer, Questioning, Non-binary, Asexual and Intersex members of our community and to let you know that the Town is committed to creating a safe and welcoming community.
