The Open House provides an opportunity for questions and to provide feedback prior to the Statutory Public Meeting that follows. The Secondary Plan applies to the Premier Gateway Phase 2B Employment Area as shown on the map.

#### Proposed policies for the Secondary Plan include:

- Similar policies to the Premier Gateway Phase 1B Secondary Plan, to allow for a consistent development approach within the overall Premier Gateway area.
- Policies related to growth management, servicing, transportation, cultural heritage, natural heritage and sustainability.
- Schedules for land use, cultural heritage, natural heritage, and transportation; and,
- Urban Design Guidelines

#### Legal Notices Required Under the Planning Act:

1. The Planning Act requires that a Statutory Public Meeting must be held on any proposed amendments to the Official Plan and that an Open House be held to ensure that the public has an opportunity to review and ask questions about the information being provided in advance of the Statutory Public Meeting.
2. If a person or public body would otherwise have an ability to appeal the decision of the Council of the Town of Halton Hills to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the Town of Halton Hills before the proposed Official Plan Amendment is adopted, the person or public body is not entitled to appeal the decision.
3. If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Town of Halton Hills before the proposed Official Plan Amendment is adopted, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.
4. Any written comment/objection submitted to the Town of Halton Hills regarding the Proposed Official Plan Amendment may be made public as part of the process.
