# 5. Importance of Naloxone Kits

Mayor A. Lawlor announced the following:

Over the weekend, Halton Regional Police Services responded to two separate instances of suspected opioid poisoning and as a result there were three people who died in Halton Hills. I want to offer my condolences to the family and friends of those people. While I do not know the circumstances of these deaths, I do know that substance abuse is a very serious problem throughout our community.

Those suffering from this addiction should carry naloxone which can temporarily reverse an opioid overdose until the individual can be transported to hospital for treatment. There are first aid kits available free of charge with no questions asked at Halton Region Harm Reduction services, sexual health clinics and most pharmacies. Due to the possibility

of opioid contamination or poisoning with street drugs, it is recommended that naloxone be used in all suspected drug poisoning.

The Halton Regional Police Services have also reminded us that the Good Samaritan Drug Overdose Act provides legal protections for anyone seeking emergency support during a drug poisoning including the person experiencing the poisoning. I will be reaching out to Halton Public Health to ensure that naloxone is readily available in our community.

# 6. 80<sup>th</sup> Anniversary of D-Day

Councillor A. Hilson announced the following:

The Acton Legion is holding a wreath laying on June 6<sup>th</sup> recognizing the 80<sup>th</sup> anniversary of D-Day. The Normandy landings marked a significant turning point in the Second World War with Canadian troops garnering recognition for their landings on Juno beach and other contributions. The Legion's wreath lying will be at the Acton Cenotaph at 11:30 am but I encourage residents to mark the day in whatever way seems fit for them.

# 7. Downtown Georgetown Farmer's Market

We have our Downtown Georgetown Farmer's Market starting up this Saturday June 1<sup>st</sup>. We have a new BIA Manager, Maureen Turner for Downtown Georgetown, who has been working with vendors to get everything set up. We have returning vendors and new vendors this year and I encourage everyone to visit and check it out.
