1. Halton Hills Climate Action

3. Acton Firefighters Association – Canada Day Fireworks

Councillor Somerville announced the Acton Firefighters Association is once again holding fireworks celebrations on July 1st. Parking at Prospect Park will be \$20 per vehicle to help offset the show's expenses. Downtown Acton merchants will be handing out Canada Day swag at the entrance and there will be some onsite vendors and other goodies available. The fireworks begin at dusk at Prospect Park. Just a reminder for people to be respectful of parking, and to make sure you're parking in proper areas.

Residents are currently allowed to purchase and discharge fireworks in accordance with our by-law. On Canada Day, and only on Canada Day residents in Halton Hills can discharge fireworks. Fireworks are not to be discharged in any park, parking lot, highway or other public place.

No fireworks can be discharged after 11pm.

No person shall discharge any fireworks in such as place or manner that creates a danger or nuisance to any person or property.

So please be respectful of your neighbours, enjoy your Canada Day, but those are the rules that will be in place on July 1st while Council continues come discussions on fireworks.

NOW THEREFORE BE IT RESOLVED THAT Council direct staff to retain a consultant to conduct a statistically valid survey as soon as possible to determine the community's thoughts on whether or not to implement a ban on the sale and discharge of fireworks (given the results of the impacts on the wildlife and environment report);

AND FURTHER THAT Council directs staff to bring forward a report at a future meeting to present the results of the survey including any comments received, with options for Council to consider to make a decision how to proceed with fireworks in Halton Hills.
